



LEE HALL ACADEMY HOME-SCHOOL AGREEMENT

This home-school agreement is based on the belief that education at Lee Hall Academy is a partnership between staff, parents / carers and pupils. This agreement outlines that the school has of parents, carers and pupils and that parents, carers and pupils can have of the school.

At Lea Hall Academy our staff team will:

- Provide your child with a high standard of education delivered through a broad and balanced curriculum, effectively adapted to meet their individual needs.
- Set differentiated and achievable opportunities to extend the curriculum and provide the opportunity for independent learning.
- Ensure that the learning environment is stimulating and appropriately resourced.
- Celebrate the academic and personal achievements made by your child.
- Provide the support and scaffolding needed to enable your child to meet their full potential.
- Use careful planning and observation to ensure that the wellbeing and safety of your child is fully met.
- Teach your child to develop a positive attitude and respect for others, regardless of their gender, race, culture, beliefs, values, age and needs.
- Encourage your child to become an active member within our community and help them to see that they can have an impact on the world around them.
- Regularly meet with you to communicate the progress of your child, celebrating their strengths and explaining how we can support them in their areas for development.
- Provide information to you about our school, including relevant policies, through the school website, meetings, workshops, activities, newsletters, and open days.

As a parent or carer of a child at Lea Hall Academy I will ensure that:

- My child attends each day where possible and has the highest attendance possible.
- My child is wearing school uniform and where school uniform items are not available, may have been lost or damaged, seek a replacement as soon as possible. (Where uniform items are missing, the school will lend the child the missing uniform until the parent/carer is able to replace the item).
- My child comes to school well rested, having an appropriate amount of sleep for their age and have a clear home routine around bedtimes.
- My child takes all prescribed medications following GP instructions, ensuring an adequate supply is kept at home and where necessary at school. All paperwork permitting school to dispense prescribed medication on site will be completed fully and returned to school in a timely manner when necessary.



- When issues have arisen where my child has not followed the GP's instructions regarding medication, I will inform school at the earliest opportunity, so the school has enough time to plan appropriate support for my child. I will also ensure that an appropriate person is available to collect my child within the school day should the need arise, due to the child being unmedicated and therefore being deemed unsafe to remain in school.
- I support the school's use of sanctions by re-enforcing appropriate sanctions at home where appropriate, following discussion with a member of SLT or the Pastoral team.
- I inform school of incidents that may affect the behaviour and safety of my child in school so that appropriate support can be put in place by the school to support my child's needs.
- I attend all formal meetings regarding my child, called for by the school, which may include meetings involving external agencies, either on the school site, another place or meeting or online on Microsoft Teams.
- I support the school by encouraging my child to develop a positive attitude towards our diverse, multi-cultural community.
- I read all information sent home as this gives me important details of relevant policies, meetings, workshops, activities, newsletters and open days.
